- 2) Yola (Gombe, Bauchi, Yobe, Taraba and Borno)- 6<sup>th</sup> July 2024
- 3) Kano (Kano, Kaduna, Jigawa, Zamfara, Katsina, Sokoto and Kebbi)- 2<sup>nd</sup> July 2024

## **WESTERN ZONE**

- 1) Ibadan (Osun, Ekiti and Oyo)- 13<sup>th</sup> July 2024
- 2) Benin- (Delta, Ondo and Edo)- 6<sup>th</sup> July 2024
- 3) Lagos State (Ogun and Lagos)- 3<sup>rd</sup> July 2024
